Prof. Catherine Barnard, University of Cambridge, UK

Prof. Catherine Barnard teaches European Union and Employment Law at the University of Cambridge and is a fellow of Trinity College. She has an MA from the University of Cambridge, an LL.M. from the European University Institute, and a PhD from Cambridge. She holds a Jean Monnet Chair of European Integration and is co-director of the Centre for European Legal Studies at Cambridge University. She was formerly Assistant Dean and the Jean Monnet Chair of European Integration at the University of Southampton. Professor Barnard is a leading expert on EU internal market and employment law and has published extensively in these fields. She is a senior fellow of "The UK in a Changing Europe".

Dr. Sara Clavero, Queen's University Belfast, Northern Ireland

Dr. Sara Clavero is research fellow at Queen's University Belfast and TREUP's research officer. She has a long experience as a researcher on comparative gender politics and policy in Europe at the national, regional and EU levels of governance. Her main research interests lie on the gender dimensions of EU social policy, European integration and multi-level governance, gender and research, and feminist philosophy. She is presently researching on gender and institutional change in higher education and research institutions, the social dimension of EMU, and the gender impacts of austerity policies in Spain.

Dr. Stephen Coutts, Dublin City University, Ireland

Dr. Stephen Coutts is a Lecturer in Law at Dublin City University, where he is a member of the Socio-Legal Centre and an associate of the Brexit Research and Policy Institute. He teaches in public law and legal theory and his research interests focus on EU citizenship, EU constitutional law and fundamental rights and the Area of Freedom, Security and Justice. He also has an interest in citizenship theory and law and political theory. He is a member of the editorial board of the Irish Journal of European Law and on the editorial team of European Papers. He has published and presented widely in the field of European law. Prior to teaching at DCU, Stephen completed a PhD in the European University Institute in Florence.

Prof. Mary Daly, University of Oxford, UK

Prof. Mary Daly is Professor of Sociology and Social Policy at the University of Oxford. She received her PhD in social and political sciences from the European University Institute and taught at Georg-August-Universität Göttingen, Germany and Queen's University Belfast before joining Oxford in 2012. Her research interests and expertise are primarily focused on the comparative analysis of social policy in advanced OECD countries. Dr. Mary Dobbs, Queen's University Belfast, Northern Ireland

Dr. Mary Dobbs is a lecturer in law at Queen's University Belfast. She undertakes research that focuses on European environmental law in particular, with a specific focus on genetically modified crops. She has examined this issue from the perspective of risk regulation, governance and agricultural sustainability. In doing so, her research has taken her across the 'public-private divide' through most recently considering the impact of 'enclosure' of plant genetic resources through patenting upon agricultural sustainability. Mary engages regularly with stakeholders and civic bodies, including more recently through participating in Brexit events that consider the challenges and opportunities for Northern Ireland in the case of a 'hard Brexit'.

Dr. Delia Ferri, NUI Maynooth, Ireland (tbc)

Dr. Delia Ferri is a Lecturer in Law at Maynooth University, where she lectures primarily in the fields of EU law and International and European Disability Law. She is a member of the Maynooth Centre for European and Eurasian Studies and an affiliated researcher at the Dirpolis Institute of Scuola Superiore Sant'Anna (Italy) within the research cluster on social rights, social inclusion and disability. Dr. Massimo Fichera is Academy of Finland Research Fellow at the Faculty of Law, University of Helsinki. He was previously, in the same University, Lecturer in European Studies at the Network for European Studies, and Post-Doctoral Fellow at the Faculty of Law. His area of expertise is European Union law. He holds a Chair in European Law also at the University of Turku, Finland. Professor Snell serves as a Joint Editor for European Law Review and is a Member of the Editorial Board of European Business Law Review. His main research interest is European economic integration. He is currently writing a monograph on Principles of Internal Market Law for Oxford University Press, and is editing a research handbook on internal market law for Edward Elgar together with Professor Panos Koutrakos of City University London.

Prior to joining the SSW team, Dr. Stephen Terrett was a legal advisor to a number of international law firms in Warsaw. He also worked in the Polish Constitutional Tribunal.

Prof. Frank Vandebroucke, University of Amsterdam, The Netherlands

University Professor at the University of Amsterdam (UvA), and Herman Deleeck chair at University of Antwerp (UA, Belgium). His research focuses on the impact of the EU on the development of social and employment policy in the EU Member States. Prof. Vandebroucke studied economics in Leuven and Cambridge, and received his D.Phil. in Oxford, was Minister for Social Security, Health Insurance, Pensions and Employment in the Belgian Federal Government (1999-2004) and Minister of Education and Employment in the Flemish Regional Government (2004-2009). He was closely involved with the launching of the EU's Lisbon Strategy in 2000, notably with the development of its social dimension. Although he was full-time engaged in politics until 2011, he published in international journals and Belgian social policy journals.
